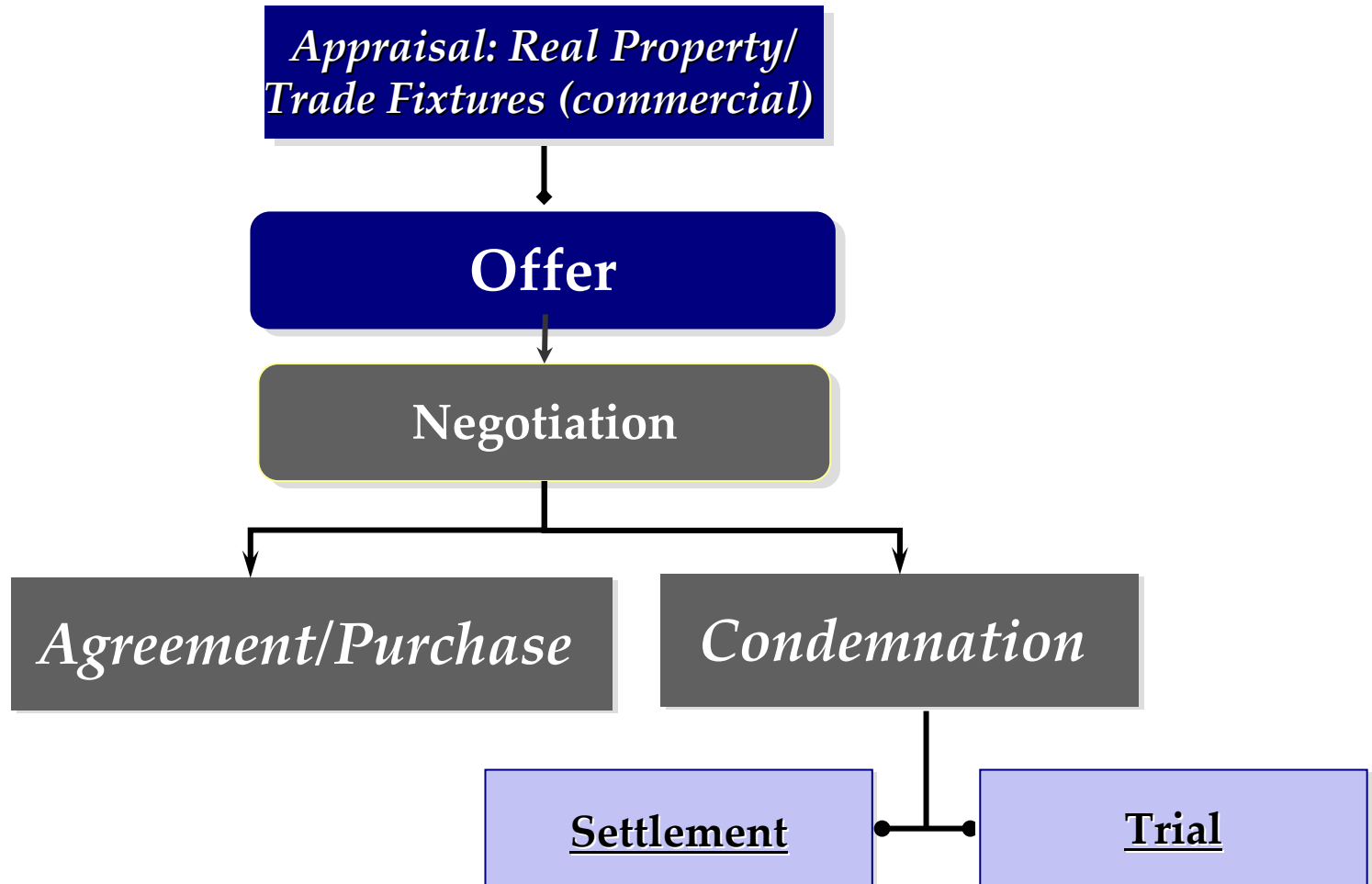

COMPARABLE REPLACEMENT DWELLINGS

LAW: FEDERAL UNIFORM ACT

DEFINED AS:

- Decent, safe, and sanitary
- Functionally equivalent
- Adequate in size to accommodate the occupants
- In an area not subject to unreasonable adverse environmental conditions
- In a location not less desirable
- On a site that is typical in size
- Currently available
- Within the financial means of the displaced person

AVAILABILITY OF COMPARABLE REPLACEMENT DWELLINGS

LAW: FEDERAL UNIFORM ACT

STEPS:

- Person informed of the comparable replacement dwelling's location
- Person has sufficient time to negotiate
- Person to be displaced is assured of receiving the relocation assistance in sufficient time
