# THE DDC CONTINUES WORK ON THE EAST 59TH STREET TRUNK WATER MAIN PROJECT

The New York City Department of Design and Construction (NYCDDC) is managing a project to reconstruct existing water mains and utility infrastructure in the vicinity of the Queensboro Bridge. A significant element of the project is the construction of new trunk water mains that will connect to a shaft distribution chamber of City Water Tunnel No. 3. Curbs and sidewalks will be replaced where necessary. The anticipated project completion date is Summer 2013.

#### **PROJECT STATUS**

Con Edison electric relocation and upgrade work is currently being performed in preparation of the trunk water main installation work.

#### **WORK COMPLETED AS OF FEBRUARY 2011**

Installation of 8" and 20" gas main

- Intersection of E. 59th St. and 1st Ave.

## Installation of 16" high pressure gas main

- 1st Ave. between E. 59th St. and E. 60th St.

# Installation of 20" gas main

- 2<sup>nd</sup> Ave. between E. 58<sup>th</sup> St. and E. 59<sup>th</sup> St.

#### Installation of 8" gas main


- E. 59th St. between 2nd Ave. and 3rd Ave.

# **WORK SCHEDULED: MARCH/APRIL 2011**

Con Edison electric relocation and upgrade work will continue throughout the project limits.

# SANITATION PICK UP - EAST 59TH STREET BETWEEN 1ST **AVENUE AND 2ND AVENUE**

Due to the New York City Department of Design and Construction's (NYCDDC) installation of construction safety barricades, access to the south curb line on East 59th Street between 1st Avenue and 2nd Avenue continues to be restricted. In order to ensure proper sanitation pick up, please remember to place all trash bags at the designated sanitation pick up point on the block. Failure to do so may result in 1) trash not being picked up, and/or 2) summons issued by The City of New York Department of Sanitation to the building in violation. Residential sanitation pick-up will be coordinated by DDC with The City of New York Dept. of Sanitation. All businesses are advised to contact their private carting company (as applicable) to coordinate private sanitation pick up. Please place your trash bags in the nearest designated area to ensure pick up.
