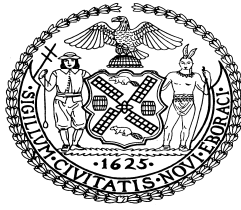

- 1. Convent of the Sacred Heart to close East 91<sup>st</sup> Street between Fifth and Madison Avenue on Thursday, June 6, 2013 from 12:00PM to 3:00PM for a Block Party**

This application was calendered in December 2012 and again at this meeting.

The applicant did not appear at either meeting.

**Motion to disapprove: 3-0-0.**

- 2. China Institute to close East 65<sup>th</sup> Street between Lexington and Park Avenue on Sunday, February 10, 2013 from 11:00AM to 12PM for a Block Party**

This event to celebrate the Chinese New Year is in its 10<sup>th</sup> year. A performance of the Lion Dance Troop, it takes place in front of the Institute and is open to the Public.

- 3. Temple Israel of the City of New York to close East 75<sup>th</sup> Street between Lexington and Park on Sunday, February 24, 2013 from 11:00AM to 3:00PM for a Religious Ceremony.**

This event is a party to celebrate the Festival of Purim and has been held annually for many years. While intended for the Congregation members and not advertised to the public, any one is welcome. It includes vendors, rides for children

- 4. Church of the Holy Trinity to close East 88<sup>th</sup> Street between First and Second Avenue on Saturday, May 4, 2013 from 11:00AM to 5:00PM for a Block Party**

This at least 25-year old event is a fund raising fair for Church ministries including shelter, supper and lunch programs, Thanksgiving home-meals, etc. It includes live music, games for children and is open to the public.

- 5. Central Park Precinct Community Council to close East 60<sup>th</sup> Street between Fifth and Madison Avenue on Sunday, June 30, 2013 from 12Noon to 5:00PM for a Block Party**
- 6. Central Park Precinct Community Council to close East 60<sup>th</sup> Street between Fifth and Madison Avenue on Sunday, September 22, 2013 from 12Noon to 6:00PM for a Block Party**
