- 1. Public Hearings re: applications for Single Block Street for calendar year 2014.
- A. Application by the Church of the Holy Trinity to close East 88<sup>th</sup> Street from First to Second Avenues on Saturday, May 3, 2014 for a Block Party.

This event will be open to the Public. No cooking of food will take place on the block. There will be general vendors and entertainment. The event has been held for 20 years.

Motion to approve passed 2-0-0. Yes: White, Chocky

B. Application by Marymount Manhattan College to close 71<sup>st</sup> Street between Second and Third Avenues, on Wednesday, May 7, 2014 from 12noon to 3:00PM for a Block Party.

This is their 44<sup>th</sup> Annual Strawberry Festival celebrating the end of the school year. It is not a graduation party and the public is invited. Food will be served, but no cooking will take place on the street. There will be music and entertainment.

C. Application by Ronald McDonald House to close East 73<sup>rd</sup> Street between First and York Avenues, on Saturday, May 17, 2014 from 11:00AM to 3:00PM for a Block Party.

This is the end of a Walkathon. This event is to highlight their Greek Program at Ronald McDonald House. (They have a large number of Greek Children staying there while they are being treated at the hospital). The public is encouraged to attend. There will be music and food donated by restaurants. No cooking will take place on the block.
