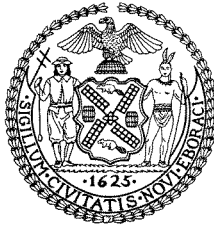

At the May 14, 2014 Land Use meeting of Manhattan Community Board 8, the following recommendation was adopted by a vote of 39 in favor, 1 opposed, and 4 abstentions.
