### 6. New Business

a. Several committee members expressed a desire to see a number of additional questions included on the CB8 questionnaire required of all applicants. It was agreed that all committee members would be sent copies of the current application package and asked to

submit recommended changes/additions/deletions to the chairs and board office. The goal will be to have an updated application package ready for approval by the end of the summer.

b. The committee discussed a request from CB8 Queens to support two pending pieces of legislation concerning the SLA and Community Boards. It was agreed that the bill concerning liquor store (retail) licenses was not particularly relevant to our district. The second bill concerned the creation of a dedicated Community Board liaison at the SLA and increasing the notice required for on premise licenses. The committee decided to consider taking a position on this legislation at our June meeting. A copy of the legislation and the letter from CB\* Queens will be provided to all committee members prior to that meeting.
