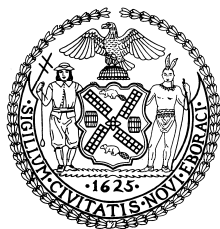

Dear Commissioner Forgione:

At the July 14, 2015 Second Avenue Subway Task Force Committee meeting, the committee passed the following resolution to **approve** by a vote of 9 in favor, 2 opposed, 0 abstentions:

**WHEREAS** New York City Department of Transportation Borough Commissioner Margaret Forgione presented information regarding restoration of the Second Avenue streetscape, including details regarding lighting, street furniture and plantings. Following questions and comments from the public and members of the Second Avenue Subway Task Force, the following resolution was proposed and voted on:

**BE IT RESOLVED** that Community Board 8 urges the New York City Department of Transportation to investigate and explore as an alternative to the City Light the feasibility of installing the TBTA Style and TBTA Shielded Teardrop Style streetlight on Second Avenue as part of the streetscape restoration between 105<sup>th</sup> Street and 64<sup>th</sup> Street, and provide a report at the next meeting of the Second Avenue Subway Task Force.
