A. Introductions were made by everyone present.

- B. Presentation on PS 290 Principal Sharon Hill, with the PTA Co-Presidents Frank Fuchs and Marina Niceta de Palazzi
 - PS 290 is located at 311 East 82nd Street and has an enrollment of 673 students, while the school has been able to enroll all the students from their wait list, the school is crowded.
 - The school embraced the Common Core Standards wholeheartedly as they reflected the standard of education that the school had already been providing literacy is integrated across the curriculum and mathematics does not focus on memorization, but rather on understanding mathematical concepts and how to unpack them.
 - Teachers are provided extensive professional development and are given the opportunity to collaborate and understand instruction across levels.
 - The PTA funds professional development opportunities for the teachers.
 - The PTA strives for 100% participation where every family donates no matter how large or small. However no one is obligated to give money.

C. Update on Rhinelander Children's Center by Ellen Santoro, Early Childhood Director

- Children's Aid Society has decided to sell the property at 350 East 88th Street. The school will close at this location in June, 2014.
- Both the parents and the teachers of the Rhinelander Children's Center are working on becoming a 501 c 3 and they are investigating two potential locations in the neighborhood. (They own the name.)
- They need to raise \$250,000 to accomplish this goal. This will allow them to continue their scholarship program, in which many of the children take part. They also have payment plans for the parents.
- The early childhood programs are for ages 2 ½ to 5 and there are after-school programs. They serve about 400 children, Programs run from Monday to Friday, 9 am to 6 pm, depending on the program.
- The afterschool program picks the children up after school and they are at the center until 6. Part of the program is help with homework.
- 90% of the children in attendance feed into the public schools in the surrounding neighborhood. This is truly a local school.
- They start teaching the Common Core standards and enrichment classes and this is a safe haven for these children.
- **D.** Update on new Middle School at PS 158
 - The new middle school has a number M177.
 - The principal will not be selected until January, 2014. It is a 50/50 screened and limited unscreened school. More information will be forthcoming on how this will work, once the new Principal is in place.
 - Parents will do their middle school admissions in the fall and state their choice.

- There will be another round of school fairs for the New Middle Schools in NYC in about February. At that time M177 will be represented and the parents can make a second admission application for M177 if they are interested.
- The outcome will be that notifications are passed out in spring, your child may possible be accepted to two schools.
- There will be an update next month, if we have any additional information.
