- A. Museum Mile to close Fifth Avenue between East 82nd and East 105th Streets on Tuesday, June 9, 2015 from 6:00PM to 9:00PM for a Street Festival

 This annual festival now in its 37th year is a non-commercial event run by the Museum Mile Committee comprised of members from each of the 8 participating museum. One new museum, the African Center on 110 Street, will participate this year although the Avenue closing will continue to end at 105th Street. It is estimated that approx. 40,000 people attend.  This annual event since 1945 when it was first held to honor returning veterans from World War 2 is open to all. Run by volunteers. There is minimal cleanup afterward.

- D. Gracie Square Art Show to close East End Avenue from 84th to 89th Streets on Saturday, October 3, 2015 to Sunday, October 4, 2015 from 10AM to 5PM for the annual Art Show The applicant stated that the event will end at 88th St., not 89th St. In its 43rd year, this event has been named one of the top 100 Art Shows in America. Over 100 artists participate. It is run almost entirely by volunteers; All proceeds go toward the maintenance of Carl Shurz Park. A small food concession will be run by a local restaurant that will also donate breakfast to the participating artists. Open to public; approx.; approx. 3000 attend.
