#### 5. Elected Official's Reports:

- Brice Peyre, a representative from Congress Member Carolyn Maloney's office presented on the latest updates. The Congress Member has received a response from the New York District, Corps. Of Engineers in regards to her letter stating her concerns over the permit application from the NYC Dept. of Sanitation to dredge and construct pile-supported structures in the East River to replace and upgrade the East 91<sup>st</sup> Street Marine Transfer Station. The bad news is that the Army Corps will not conduct an additional public hearing for this permit review. The good news is that the Army Corps. is extending the comment period to submit written testimony from the public. On November 3<sup>rd</sup>, Congresswoman Maloney along with Senator Charles Schumer, Senator Kirsten Gillibrand, and U.S. Representatives Joe Crowley, Peter King, Charles Rangel and Steve Israel announced that they have successfully secured for the Centers for Medicare and Medicaid Services (CMS) rule change to boost Medicare funding to Memorial Sloan-Kettering Cancer Center by \$28 million a year for outpatient services reimbursement. She was also very pleased to attend the ground-breaking ceremony for the new 18-story medical research building for the Weill Cornell Medical College at east 69<sup>th</sup> Street between York and First Avenues. Despite proposed cuts by Republicans to gut the East Side Access and Second Avenue Subway projects, Council Member Maloney noted the inclusion of \$186,566,000 in federal funding in next year's budget for the Second Avenue Subway project and \$203,424,000 for the East Side Access project.
- Patrick Madigan, a representative from New York State Senator Liz Krueger's office, reported the latest updates. The Senator's Senior Roundtable 2011-2012 Program Series "Planning Ahead: Senior Living in the 21<sup>st</sup> Century" is being held Thursday, November 17<sup>th</sup>, 8AM-10AM, at Lenox Hill Neighborhood House, 331 East 70<sup>th</sup> Street. Senator Krueger held a hydrofracking meeting on Wednesday for the community to voice their opinions on this issue. On October 26<sup>th,</sup> the Senator sent out a letter to the Administrator of the Federal Aviation Administration (FAA) urging the FAA to implement a long term ban on all tourist and recreational flights over and around Manhattan. Tomorrow, November 17<sup>th</sup>, Senator Krueger will be holding an informal community meeting with the MTA which will focus on specific concerns with the Second Avenue Subway construction. The MTA has agreed to hold monthly meetings with representatives of certain buildings who have specific concerns or unique issues.
- Ricki Gunsburg, a representative from Assembly Member Micah Kellner's office, reported on the issues that he is currently working on. She gave an update on the Second Avenue Subway construction in regards to the Occupational Safety and Health Administration (OSHA) report. OSHA's preliminary findings found that there is no carbon monoxide and the noise is within acceptable levels. In addition, Assembly Member Kellner has called in the Environmental Protection Agency (EPA) and the NYS Department of Environmental Conservation (DEC) to monitor any health hazards from Second Avenue Subway construction. The DEC will be holding a public hearing on hydrofracking, November 30<sup>th</sup>, at the Tribeca Performing Arts Center, at 199 Chambers Street, NYC 10007. There will be 2 sessions: 1PM-4PM and 6PM-9PM. The Assembly Member's office will be compiling citizen testimony which will be delivered at the hearing. Update and Discussion on the legal status of Electric-Assisted Bicycles and proposed legislation affecting that status (joint item with Street Life and Public Safety Committees)

**WHEREAS** Community Board 8M currently requires all applicants for Department of Consumer Affairs Sidewalk Cafe permits and State Liquor Authority licenses to agree to certain stipulations, and

WHEREAS, among these stipulations is an agreement to abide by New York City's delivery bicycle regulations, and

WHEREAS, many establishments have recently begun using motor-assisted bicycles for delivery, and WHEREAS, both the NYPD and the NYS Department of Motor Vehicles have issued public documents or statements that use of such vehicles on any streets, highways or sidewalk located in NY State is illegal, THEREFORE BE IT RESOLVED, that Community Board 8M will add to its list of stipulations for all DCA and SLA applications a requirement that the applicant agrees not to use motor-assisted bicycles for deliveries, and BE IT FURTHER RESOLVED, that this policy will be reviewed if the legal status of motor-assisted bicycles is changed by legislation or court decision.

• Landmarks Committee – David Liston and Jane Parshall, Co-Chairs

**Re: 851 Lexington Avenue (between 64<sup>th</sup> and 65<sup>th</sup> Streets) – Upper East Side Historic District Extension** – *Chon Engineering P. C.* Application is to modify storefront infill installed without Landmarks Preservation Commission permits.

WHEREAS, 851 Lexington Avenue is an altered neo-Grec style rowhouse designed by Robert H. Coburn and constructed in 1880-81.

**WHEREAS**, 851 Lexington Avenue is a 4-story building with a commercial use at the ground level and residential units above.

**WHEREAS**, the applicant proceeded with storefront infill without Landmarks Preservation Commission approval; the applicant felt that the storefront façade at the ground level was in a state of extreme disrepair. **WHEREAS**, this existing condition received a violation; the applicant is now proposing a revised storefront design to replace the existing design.

**WHEREAS**, the new design includes a thinner frame for all the elements of the storefront, including the windows and doors.

**WHEREAS**, the new design includes two side-by-side entry doors that will replace the single door so that the entry provides handicapped accessibility.

WHEREAS, the new design is not an improvement over the existing illegally installed storefront.

THEREFORE BE IT RESOLVED that this application is disapproved as presented.

Manhattan Community Board 8 adopted this recommendation by a vote of 44 in favor, 0 opposed and 1 abstention.

**Re: 40 East 72<sup>nd</sup> Street (between Madison and Park Avenues) – Upper East Side Historic District** – *Barry Rice, Architect.* Application is to add additional floors.

**WHEREAS,** 40 East 72<sup>nd</sup> Street is a 5-story, 49' wide building constructed in 1881 by Robert B. Lynd and altered in the neo-Classical style in 1928 by Schwartz & Gross.

**WHEREAS,** 40 East 72<sup>nd</sup> Street is on the south side of 72<sup>nd</sup> St. at the midblock; the applicant received a Certificate of Appropriateness from the Landmarks Preservation Commission in 2003 to add 3 stories to the top of the existing building.

**WHEREAS**, the applicant is now requesting a Certificate of Appropriateness for a taller building that will be set back 20' from the street wall (5' feet further back from the street wall than existing zoning requires).

**WHEREAS**, the applicant intends that, because of the 20' setback, the new construction will read as a separate building that is discreet from the designated contributing building within the historic district.

**WHEREAS,** while the new building is not visible looking south from Park Avenue, it becomes visible at about  $1/3^{rd}$  of the way into the block.

**WHEREAS,** the existing 5-story building is to be fully restored; however, the applicant proposes that the windows in the Schwartz & Gross 1928 alteration be incrementally widened.

**WHEREAS,** the new 10-story building, while made of brick, will not be in the same brick as the building below, so that it presents as "purposefully different", but will fit in massing and scale with the neighboring apartment buildings.

**WHEREAS,** the new 10-story building will contain approximately 37,000 sq. ft. which is less than the 46,000 sq. ft. allowed under the zoning (FAR).

**WHEREAS** the front of the new 10-story building will be articulated, with 1' setbacks on either side with a middle shallow bay-window that protrudes out 1' in the middle of the elevation.

**WHEREAS**, the height of the building to the top of the roof will be 167'7" and to the top of the mechanicals 176'.

**WHEREAS,** the applicant intends for the new 10-story building to read visually as the rear elevation of a building, i.e., if one were to look across the existing 5-story building from 72<sup>nd</sup> Street – <u>because of the 20'</u> <u>setback</u> -- the new construction would present as a separate building that could be in an imaginary rear yard. [The intent of the 20' setback is to make the new construction read as if it were behind and not attached to the Schwartz & Gross 5-story contributing building so that the 5-story Schwartz & Gross contributing building would be perceived as a building separate from the new construction.]

**WHEREAS,** the intent of the proposed window enlargements on the 5-story Schwartz & Gross building is so that the windows in the new building above could be aligned to the building below; however their enlargement will change forever the character and design of the Schwartz & Gross contributing building.

**WHEREAS**, the existing 5-story Schwartz & Gross building contributes to the character of the historic district; the Landmarks Commission reaffirmed this when it approved the as-yet-unbuilt 3-story addition in 2003.

**WHEREAS**, enlargement of the windows in the Schwartz & Gross building would change the proportions of the 1928 alteration.

**WHEREAS,** the 20' setback reads as a "setback", not as a "rear elevation" of a building in the rear yard behind. **WHEREAS,** the applicant did not present any drawings for the rear (south elevation facing 71<sup>st</sup> St.) of the proposed new construction.

**WHEREAS**, the integrity of the contributing Schwartz & Gross building within the historic district must be maintained.

**WHEREAS**, the proposed 10-story building set on top of the 5-story Schwartz & Gross contributing building is inappropriate and out-of-context within the historic district.

**THEREFORE BE IT RESOLVED** that this application is **disapproved** as presented.

Manhattan Community Board 8 adopted this recommendation by a vote of 44 in favor, 0 opposed and 1 abstention.

Re: Plan to Reconstruct Central Park's North Harlem Meer Landscape, Shoreline and Playground

**WHEREAS** The Central Park Conservancy has proposed a preliminary plan for restoring the Harlem Meer landscape, shoreline and playground that calls for enhancing the safety, accessibility and overall usability of the space; and

**WHEREAS** specific plans call for reconstructing area paths to make them safer; upgrading the scenic quality of the area through additional and improved planting; making open space more usable; and replacing deteriorated equipment in the East 110<sup>th</sup> St. Playground with new and more diverse forms of play equipment; and **WHEREAS** the planned renovation of the E. 110<sup>th</sup> St. Playground would fulfill the CPC's goal of better integrating playgrounds into the overall park landscape and park experience; therefore,

**BE IT RESOLVED** that Community Board 8 Manhattan approves of the Central Park Conservancy's preliminary plans for the reconstruction of the North Harlem Meer landscape, shoreline and playground. **Manhattan Community Board 8 adopted the resolution by a vote of 45 in favor, 0 opposed and 0 abstentions.** 

## **Re: Plan to Reconstruct the Landscape in the Reservoir East Area of Central Park**

**WHEREAS** the landscaping, irrigation system and pathway in the Reservoir East area of Central Park have become deteriorated, requiring reconstruction; and

**WHEREAS** proposed new plantings and soil regradings would improve the appearance of the area, restore some of the previously existing scenic elements, such as the extensive rhododendron plantings, and generally better integrate this area into the overall design of Central Park; and

**WHEREAS** proposed new landscaping would better screen out views of 5<sup>th</sup> Avenue and other cityscapes for those in the Reservoir East area, enhancing their park experience; therefore,

**BE IT RESOLVED** that Community Board 8 Manhattan approves of the Central Park Conservancy's plan to reconstruct the landscape in Central Park's Reservoir East area—a section of Central Park that runs along both sides of the East Drive from E. 86<sup>th</sup> St. to E. 96<sup>th</sup> St.

Manhattan Community Board 8 adopted the resolution by a vote of 45 in favor, 0 opposed and 0 abstentions.

### Re: Plans for an Older Adults Recreation Area in John Jay Park - Substitute Motion

**WHEREAS** the growing population of older residents in the area of John Jay Park wish to have a targeted space in which to relax, read, socialize and exercise; and

**WHEREAS** these residents of Community Board 8 wish to convert the rear area of the park for adults (not in the company of children) who use the park -- with amenities including new plantings, safety surfacing, picnic and checkers tables, retrofit benches and outdoor exercise equipment designed for adults;

**WHEREAS** Jessica Lappin's office has indicated that they support the three pieces of equipment as proposed by the community;

**THEREFORE be it resolved** that Manhattan's Community Board 8 requests that the Parks Department implement the scope of work assessment and a plan/design be shown to the community, immediately.

Manhattan Community Board 8 adopted the resolution by a vote of 34 in favor, 6 opposed and 5 abstentions.
