Chair Nicholas D. Viest called the meeting to order at 6:30PM.

1. Public Hearing: BSA Calendar No. 137-12-BZ, Hospital for Special Surgery Properties Corporation, 515-523 East 73<sup>rd</sup> Street and 512-518 East 74<sup>th</sup> Street, Block 1485, Lots 11, 14 and 40-Application for the development of a thirteen-story ambulatory care facility at a through-block development site located at 515-523 East 73<sup>rd</sup> Street and 512-518 East 74<sup>th</sup> Street. The Bulk variance, pursuant to Section 72-21, varying sections 42-12, 43-122, 43-23, 43-28, 43-44 and 13-133 to waive the rear-yard equivalent along Eat 73<sup>rd</sup> Street, allow community facility Use Group 4 in a 5.59 foot wide strip of the premises, waive a 20 foot setback along East 73<sup>rd</sup> Street, increase floor area ratio and increase the number of parking spaces permitted.

**Whereas**, Application for the development of a thirteen-story ambulatory care facility at a through-block development site located at 515-523 East 73<sup>rd</sup> Street and 512-518 East 74<sup>th</sup> Street. The Bulk variance, pursuant to Section 72-21, varying sections 42-12, 43-122, 43-23, 43-28, 43-44 and 13-133 to waive the rear-yard equivalent along Eat 73<sup>rd</sup> Street, allow community facility Use Group 4 in a 5.59 foot wide strip of the premises, waive a 20 foot setback along East 73<sup>rd</sup> Street, increase floor area ratio and increase the number of parking spaces permitted.

Whereas, Community Board 8M held a public hearing regarding this matter; therefore

Be It Resolved that Community Board 8M approves this application.

Community Board 8M adopted the resolution by a vote of 36 in favor, 0 opposed, 4 abstentions and 1 not voting for cause.

2. Public Hearing: BSA Calendar No. 301-85-BZ, 58 East 86<sup>th</sup> Street, Block 1497, Lot 49-Special Order Calendar application for an amendment to a previously approved variance pursuant to Cal No. 301-85-BZ which permitted in an R10(Pl) residential district ground floor and partial cellar several specific retail uses at the building. There has been commercial use on the ground floor of this building since before the enactment of the 1916 Zoning Resolution. Variances have re-established ground floor commercial use for over 30 years. The building is located 13 feet east of a C5-1 commercial district. The amended application seeks to add several additional use group 6 uses to the list of permitted retail uses and extend the hours of operation.

Whereas, Special Order Calendar application for an amendment to a previously approved variance pursuant to Cal No. 301-85-BZ which permitted in an R10 (Pl) residential district ground floor and partial cellar several specific retail uses at the building. There has been commercial use on the ground floor of this building since before the enactment of the 1916 Zoning Resolution. Variances have re-established ground floor commercial use for over 30 years. The building is located 13 feet east of a C5-1 commercial district. The amended application seeks to add several additional use group 6 uses to the list of permitted retail uses and extend the hours of operation.

**3. Informational Presentation: The Manhattan Core Parking Study**-The Department of City Planning is exploring revisions to the off-street parking regulations in the Manhattan Core, which includes Community Boards 1-8. Since the spring of 2009, the Department has been studying these regulations to better understand how they have affected the supply of parking and how public parking is being utilized today.

BE IT RESOLVED THAT the application is Approved.

2a. Starbucks Corporation d/b/a Starbucks Coffee, 1515 York Avenue (80th/81st Street) - New application for an unenclosed sidewalk café with 18 tables and 31 seats, DCA #1427775. Due date: June 22<sup>nd</sup>. Hours: 8am – 10pm. Food/Drink: 15/85.

WHEREAS the applicant wishes to expand the size of the café,

WHEREAS there were several complaints about noise & early opening of the café in the private area, WHEREAS the applicant will furnish to CB8 all permits for the use of the current location in the public space.

**WHEREAS** the applicant will keep to the legal DCA sidewalk café times for the whole of café,

WHEREAS the applicant will clean the area on a regular basis, every 20 minutes or so,

**WHEREAS** tables will not be out for use before agreed hours of operation (the tables will be placed on site for the night but only on the property area),

WHEREAS the applicant will not place A-frames in front of the establishment,

**WHEREAS** the applicant will be denied if they participate in bar-crawls,

WHERAS the applicant will not use electronic bikes,

**BE IT RESOLVED THAT** the application is Approved.

WHEREAS the new applicant owns the building & the prior licensee was evicted,

WHEREAS the applicant will not use the rear yard,

WHEREAS the applicant will keep the back door & rear yard windows closed, except when used for normal business functions & not for patron use,

WHEREAS the applicant will furnish CB8 with a new SLA application with the 500' licenses,

WHEREAS the applicant has already furnished CB8 with the public assembly certificate,

WHEREAS the hours will be 12PM-12AM Monday thru Thursday & 12PM-1AM Friday thru Sunday,

**WHEREAS** the applicant will keep to existing C of O with 74 persons at ground level & 20 persons in the basement,

WHEREAS no one from the public objected,

**BE IT RESOLVED THAT** the application is Approved.

Manhattan Community Board 8 adopted the resolution by a vote of 28 in favor, 6 opposed, and 8 abstentions.

4g. <u>Roosevelt Island Hospitality Group, LLC d/b/a Pier NYC, West Promenade Pier, Roosevelt Island</u> - New application for an liquor, wine and beer (on-premises) liquor license. Hours: 11am – 9pm. Food/Drink: 30/70

WHEREAS this is for a short time frame – until October 2012,

WHEREAS there were several people in support of the establishment,

WHEREAS the applicant will furnish to CB8 all permits for the use of the current location in the public space, BE IT RESOLVED THAT the application is Approved.

There was a discussion of NYS Liquor Authority's 200 foot rule policy.

Manhattan Community Board 8 Resolution Endorsing the June 17<sup>th</sup> Silent March to End "Stop and Frisk"

**Whereas,** New York city Police Officers conducted 685,724 street stops in 2011, 600% more that the 97,000 that were conducted in Mayor Bloomberg's first year in office; and,

Whereas, no gun is retrieved in 99.9% of these stops; and,

**Whereas,** the proportion of gun seizures to stops has fallen – with only 780 guns confiscated in 2011, juxtaposed to 604 in 2003, when officers made 160, 851 stops; and,

**Whereas,** a 2011 report by the New York Civil Liberties Union indicates that 71% of the "stops" by the 19<sup>th</sup> Precinct on the Upper East Side of Manhattan were of black and Latino males, while only 9% of the total population in the same area is black or Latino; and,

**Whereas**, the Manhattan Borough Board passed a resolution – approved by all 12 community boards – calling for reform of stop and frisk; and,

**Whereas,** 237 Civil Rights, Faith, Labor and Community Groups – including B'nai Jeshurun; Common Cause New York; the Center for Constitutional Rights; the New York Civil Liberties Union; and Manhattan Community Board 2 – have come together to organize a "Silent March," for Father's Day June 17<sup>th</sup>, to illustrate both the tragedy and serious threat that stop and frisk and other forms of racial profiling present to our society; and, **Whereas,** Manhattan Borough President Scott Stringer has agreed to participate in the "Silent March" as part of an effort to build bridges of trust and respect in every neighborhood; and,

**Whereas,** Borough President Stringer has asked members of Community Board 8 and residents of Community District 8 to join him on June 17<sup>th</sup>; and,

**Whereas,** the march will commence on 110<sup>th</sup> Street and Fifth Avenue proceeding south to Fifth Avenue and 78<sup>th</sup> Street; and,

Whereas, the march will pass by the residence of Mayor Bloomberg on East 79<sup>th</sup> Street and Fifth Avenue, inside the boundaries of Community District 8; and,

Whereas, Manhattan Community Board 8 approved the Manhattan Borough Board Resolution Regarding NYPD's Stop and Frisk Program, at its February 15, 2012 Full Board Meeting;

**Therefore Be It Resolved** that Manhattan Community Board 8 joins with more than 237 Civil Rights, Faith, Labor and Community Groups in endorsing the June 17<sup>th</sup> Father's Day Silent March to "End Stop and Frisk." **Manhattan Community Board 8 adopted the resolution by a vote of 21 in favor, 15 opposed, 4 abstentions, and 2 not voting for cause.**
