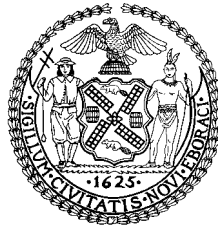

Chairman James G. Clynes called the meeting to order at 6:30PM.

1. Public Session – Those who wish to speak during the Public Session must register to do so by 6:45 pm

- **Public Hearing: N 170287 ZCM, 1802-1810 Second Avenue, Block 1556, Lots 1, 2, 3, 5, 51 & 52 C2-8 and R8B Districts, Special Transit Land Use District**-Application by Maplewood Senior Living LLC requesting a joint certification by the MTA New York City Transit and the City Planning Commission pursuant to Section 95-041 of the Zoning Resolution as to whether a transit easement volume is required on the zoning lots in connection with a development of a proprietary assisted living facility on Lots 2, 3, 51 and 52. The new building would be a 21-story, Use Group 3 community facility building containing up to approximately 167, 632 square feet of floor area. The Zoning Lot is located on the Upper East Side of Manhattan and is partially mapped within a C2-8 zoning district and partially mapped within a R8B district and located entirely within the Special Transit Land Use District.

Manhattan Community Board 8 did not take a vote on this application as it was not required.

- **Public Hearing: BSA Calendar No. 2017-100-BZ, CEQR# 17-BSA-111M, 412 East 90th Street, Block 1569, Lot 35**-Application requesting a ZR Sec. 73-19 Special Permit to allow a school use in a C8-4 zoning district and a ZR Sec. 72-21 variance for rear yard waivers to construct a 6-story education and athletic facility on the site of a former garage in a C8-4 district. The application will allow the construction on the site of a new educational and athletic facility for the Spence School.

Whereas, the application requesting a ZR Sec. 73-19 Special Permit to allow a school use in a C8-4 zoning district and a ZR Sec. 72-21 variance for rear yard waivers to construct a 6-story education and athletic facility on the site of a former garage in a C8-4 district. The application will allow the construction on the site of a new educational and athletic facility for the Spence School.

Be It Resolved that Community Board 8 approves the application for a Special Permit and variance for 412 East 90th Street.

Community Board 8 adopted the resolution (to approve the application) by a vote of 32 in favor, 1 opposed, 4 abstentions.

- **Public Hearing: ULURP Application N170187 (A) ZRM and C170187 ZSM, Greater East Midtown Proposal Amended-**Application includes proposed modifications to the zoning text certified into public review on January 3, 2017 (N170186ZRM). No modifications are proposed for the map amendment portion of the application (C170187ZSM). The application (N170186 (A) ZRM) addresses issues raised after certification of the original zoning text application (N170186ZRM), consisting of two modifications to the zoning text that requires additional environmental analysis, the focus of Technical Memorandum 001. These modifications address conditions in which landmarked buildings may prevent development on adjacent sites and circumstances whereby transit easement volumes are deemed necessary on a development site. The application also includes clarifications and modifications to the proposal that do not require additional environmental analysis including minor edits to the proposed text governing height and setback regulations, clarifications regarding the minimum contribution amount associated with the enlargement authorization, and an in-kind above grade improvement provision.

Manhattan Community Board 8 did not take a vote on this application as it was not required.

7a. NEC 2nd Avenue & East 94th Street (301 E 94th Street) – Application for a newsstand. Application #3443-2017-ANWS.

WHEREAS this is a new application for a newsstand; and

BE IT RESOLVED that the application is **DISAPPROVED**.

Manhattan Community Board 8 adopted the recommendation by a vote of 14 in favor, 21 opposed, 1 abstention and 0 not voting for cause.

b. Landmarks Committee – David Helpern and Jane Parshall, Co-Chairs

Re: 895 Madison Avenue (72nd / 73rd), Upper East Side Historic District - n/a, architect, Application is for replacement of awnings and installation of planters.

This application has been divided into two parts: Part A: The replacement of awnings; Part B: The installation of planters.

PART A: THE REPLACEMENT OF AWNINGS

WHEREAS the three awnings over the three show windows of the Paul Morelli jewelry store replace the prior awnings for Gallo Shoes;

WHEREAS the prior awnings were red and the current awnings are gray in color;

WHEREAS the current awnings are exactly the same size as the prior awnings;

WHEREAS the current awnings are made of canvas;

WHEREAS the current awnings are not retractable;

WHEREAS neither the prior awnings nor the current awnings were approved by the Landmarks Preservation Commission;

WHEREAS the current awnings must receive a Certificate of Appropriateness to remain in place;

THEREFORE BE IT RESOLVED that PART A of this application is **APPROVED** as presented.

Manhattan Community Board 8 adopted this recommendation by a vote of 36 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

PART B: THE INSTALLATION OF PLANTERS

WHEREAS two planters with boxwood project 10 inches onto the sidewalk;

WHEREAS the two planters are located against the masonry piers between the three windows;

THEREFORE BE IT RESOLVED that PART B of this application is **APPROVED** as presented.

Manhattan Community Board 8 adopted this recommendation by a vote of 20 in favor, 16 opposed, 0 abstentions, and 0 not voting for cause.

Re: 10 E 63rd Street (Madison / 5th Ave), Upper East Side Historic District - Sam Trimble, architect [Trimble Architecture], Application is for excavation below grade at the rear yard..

WHEREAS 10 East 63rd Street is a 5-story, 25' wide townhouse designed by James Ware and constructed in 1879. Remodeled by A. Wallace McCrea in 1922 in the neo-classical style;

WHEREAS there is an existing rear yard, 25' wide by 26' deep with a notch taken out for an existing extension/projection into the rear yard; the notch measures 10' wide x 10' deep;

WHEREAS the applicant proposes an excavation under the entire rear yard to a depth of 17' to extend the cellar so that the applicant may create a below-grade gym;

WHEREAS as part of the excavation project, the applicant proposes to raise the surface of the rear yard by 2'; the existing terra cotta red tile surface of the rear yard will be changed to limestone pavers;

WHEREAS access to the rear yard is now provided by an existing door in the extension; the door will be raised up to accommodate the 2' that is being added to the height of the rear yard as part of the excavation project. [On the interior, there will now be two steps up to the door that has been raised.];

WHEREAS the applicant proposes to add mechanical equipment – 3 compressor-condensing units -- enclosed in a teak trellis 14' long x 2'8" deep along the left wall of the rear yard;

WHEREAS as required by the building code, all buildings within 90' of 10 East 63rd Street will be monitored during the excavation; none of the proposed work is visible from the public way;

THEREFORE BE IT RESOLVED that this application is **APPROVED** as presented.

Manhattan Community Board 8 adopted this recommendation by a vote of 21 in favor, 15 opposed, 0 abstained, and 0 not voting for cause.

c. Transportation Committee – A. Scott Falk and Charles S. Warren, Co-Chairs

Re: Continued discussion of a request to add a “No Standing” sign at the intersection of East End Avenue & 82nd Street

WHEREAS illegally and improperly parked cars often block the exit driveway in front of 60 East End Avenue, or extend into the crosswalk at the southwest corner of East 82nd Street & East End Avenue; and

WHEREAS establishing a No Standing zone in front of the building’s exit driveway and continuing south to the corner of East 82nd Street should help alleviate this problem;

THEREFORE BE IT RESOLVED that Community Board 8M asks NYC Dept. of Transportation to change the parking regulations to “No Standing Any Time” along the western curb of East End Avenue between 82nd & 83rd Street, extending from the northern edge of the southern driveway in front of 60 East End Avenue to the southwest corner of East 82nd Street & East End Avenue.

Manhattan Community Board 8 unanimously approved the resolution by a vote of 37 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

Re: Continued discussion of a request to install a temporary bus stop on the SE corner of 83rd Street and East End Avenue.

PART 2-A, No Standing Zone for Buses:

WHEREAS the Brearley School requests to change the parking regulations to “No Standing – Buses Only” along the eastern curb of East End Avenue between 82nd & 83rd Street, extending from 75 East End Avenue to the southeast corner of East 83rd Street & East End Avenue, from 7-9 AM & 2-4 PM on school days only, from August 2017 until September 2019, when construction of the new school is completed; and

WHEREAS the traffic situation in the area is very difficult because of buses and construction; and

WHEREAS there is a concern for the safety of the children loading and unloading from the buses;

THEREFORE BE IT RESOLVED that Community Board 8M approves the Brearley School’s request to change the parking regulations to “No Standing – Buses Only” along the eastern curb of East End Avenue between 82nd & 83rd Street, extending from 75 East End Avenue to the southeast corner of East 83rd Street & East End Avenue, from 7-9 AM & 2-4 PM on school days only, from August 2017 until September 2019, when construction of the new Brearley School building is completed.

PART 2-B, Temporary Curb Extensions:

WHEREAS the Brearley School requests to install temporary painted pedestrian neckdown curb extensions at the northeast and southeast corners of East 83rd Street & East End Avenue; and

WHEREAS there is a concern for the safety of the students and others who cross the street at the northeast and southeast corners of East 83rd Street & East End Avenue; and

WHEREAS Brearley School hired Sam Schwartz Engineering to make recommendations to improve pedestrian safety at those corners; and

WHEREAS a major recommendation was to install temporary curb extensions to help students and others cross the street in a safe manner;

THEREFORE BE IT RESOLVED that Community Board 8M approves the Brearley School’s request to install temporary painted pedestrian neckdown curb extensions at the northeast and southeast corners of East 83rd Street & East End Avenue until September 2019, when construction of their new school building is completed.

Manhattan Community Board 8 unanimously approved the resolution by a vote of 37 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

d. Parks and Recreation Committee – Susan Evans and Margaret Price, Co-Chairs

RE: Central Park Conservancy: Reconstruction of the East 67th Street/Billy Johnson Playground

WHEREAS the Central Park Conservancy is proposing a \$2.5 million program to reconstruct the East 67 Street/Billy Johnson Playground in Central Park; and

WHEREAS proposed improvements would upgrade and expand the playground’s existing play features, while also making site fully compliant with current safety standards; and

WHEREAS specific changes would include: establishing a water feature at the amphitheater; replacing the existing spray bollard with a user-active spray feature; introducing a net-climbing experience in the sand area; creating a second granite embankment slide that is ADA accessible and accommodates younger children; replacing current bucket swings to comply with current safety standards; replacing deteriorated timber-lined edges of paths; and repaving the playground for ADA-accessibility; therefore,

BE IT RESOLVED that Community Board 8-Manhattan approves of the Central Park Conservancy's proposed plans for the renovation of the East 67 Street/Billy Johnson Playground in Central Park.
CB8M board voted to adopt the resolution by a unanimous vote of 37 in favor, 0 opposed and 0 abstentions.

RE: Central Park Conservancy: Reconstruction of the East 108th Street/Bernard Playground

WHEREAS the Central Park Conservancy is proposing a \$650,000 program to renovate the East 108th St./Bernard Playground in Central Park; and

WHEREAS proposed improvements would upgrade and expand the playground's existing play features, while also making site fully compliant with current safety standards; and

WHEREAS specific changes would include: Reconfiguring the swings area and replacing existing swings to comply with current safety standards; replacing the existing post-and-platform climber / composite play equipment with one that meets current safety standards; replacing the current sandbox, incorporating an accessible sand table and adding a water source for additional play value; replacing the spray bollard with a spray feature that is user-activated and saves water; and repaving the playground for ADA accessibility; therefore,

BE IT RESOLVED that Community Board 8-Manhattan approves of the Central Park Conservancy's proposals for the renovation of the East 108th St./Bernard Playground in Central Park.

RE: Central Park Conservancy: Renovation of the Belvedere Castle

WHEREAS the Central Park Conservancy is proposing an approximately \$10 million restoration of Belvedere Castle, which is one of Central Park's most visited sites; and

WHEREAS the proposed project involves comprehensively restoring the core and shell of the castle as well as creating an ADA-accessible route to the site; and

WHEREAS the extensive work on the castle would include: restoring the castle's parapet walls and terraces with effective drainage and waterproofing systems; cleaning and repointing the water damaged exterior masonry; restoring the wood pavilions, and recreating the decorative wood tower at the northwest corner; replacing windows, main entrance door, and upper terrace doors with clear glass; and refinishing the interior, modernizing mechanical systems, and upgrading utility services; and

WHEREAS the CPC is proposing to create an ADA-accessible route from the park's East Drive to the castle that involves regrading and realigning existing paths over an elevation change of 25 feet; and

WHEREAS the CPC proposes requiring the path south of Turtle Pond to have a retaining wall and parapet to accomplish the grade change, therefore,

BE IT RESOLVED that Community Board 8-Manhattan approves of the Central Park Conservancy's extensive \$10 million plans for the restoration of Central Park's Belvedere Castle, including plans for an ADA-accessible path to this site.

Manhattan Community Board 8 unanimously approved the resolution by a vote of 37 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

RE: Proposal for a Public Art Installation by Artist William Logan

WHEREAS the Parks Dept. is proposing to display a sculpture by artist William Logan at Tramway Plaza Park for a six-month period, beginning in May or June 2017; and

WHEREAS this art work entitled, "The Flame" is a tall open-lattice sculpture that captures light in a variety of ways; and

WHEREAS the Parks Department will ensure that the sculpture will be safely installed and maintained during its display at Tramway Plaza; therefore,

BE IT RESOLVED that Community Board 8-Manhattan approves of the Parks Dept.'s plan to install a work of art by William Logan in Tramway Plaza Park this year from late May to early November

RE: The Rising Costs of Repairing and Upgrading the East River Esplanade on the Upper East Side

WHEREAS The East River Esplanade continues to deteriorate, creating a dangerous, unsightly and disruptive situation for its many users; and

WHEREAS recent Parks Dept. information shows a jump in expected Esplanade repair costs, now cited as \$210 million for engineering and design work, and projected to rise further; and

WHEREAS Community Board 8-Manhattan recently passed a resolution asking for a \$169 million of public funding to add to the existing \$41 million already allocated for the Esplanade to cover known repair expenses; and

WHEREAS CB8-M and other groups concerned about the Esplanade's rising costs wish to obtain more frequent City reports on Esplanade work and repair costs; and

WHEREAS CB8-M hopes that at least quarterly meetings can be re-established between the Parks Dept. and the East River Esplanade Task force, or at least the Parks Dept. and CB8-M, on the status of Esplanade repairs; therefore,

BE IT RESOLVED that Community Board 8-Manhattan asks the Parks Dept. to re-establish at least quarterly meetings with the East River Esplanade Task Force about the status of East River Esplanade repairs. The Community Board also asks the Parks Dept. to provide CB8-M with at least quarterly reports on current repairs to the East River Esplanade and projections for future Esplanade work and its expected cost.
