- Pavement key at pedestrian Ramps.

- Roadway adjacent to newly constructed curbs.

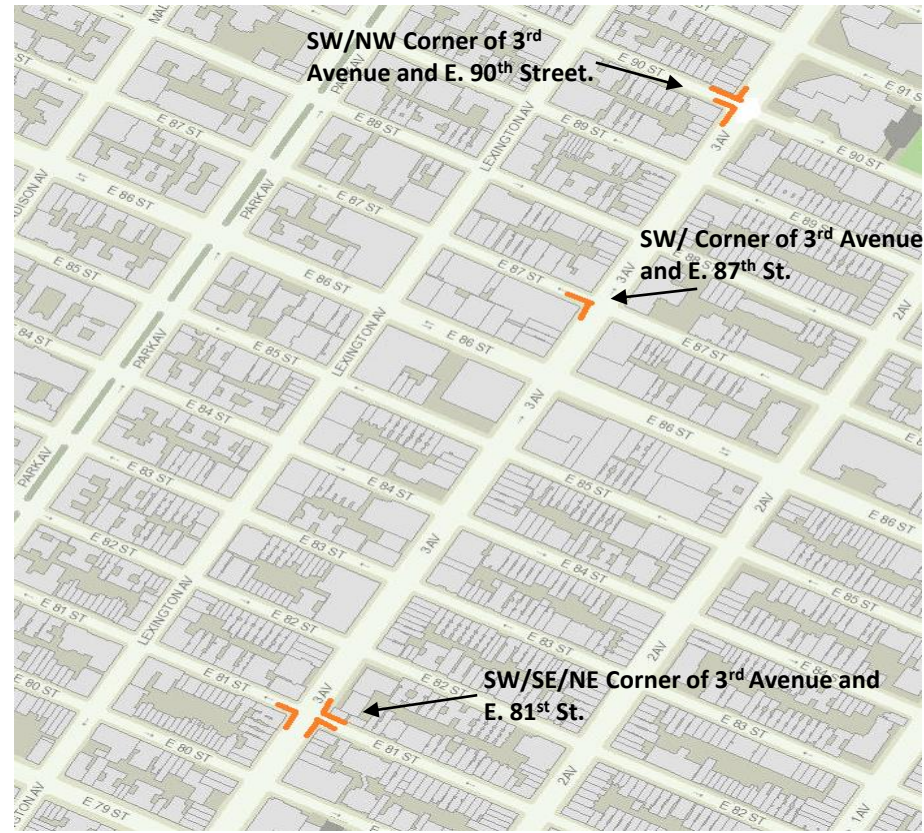
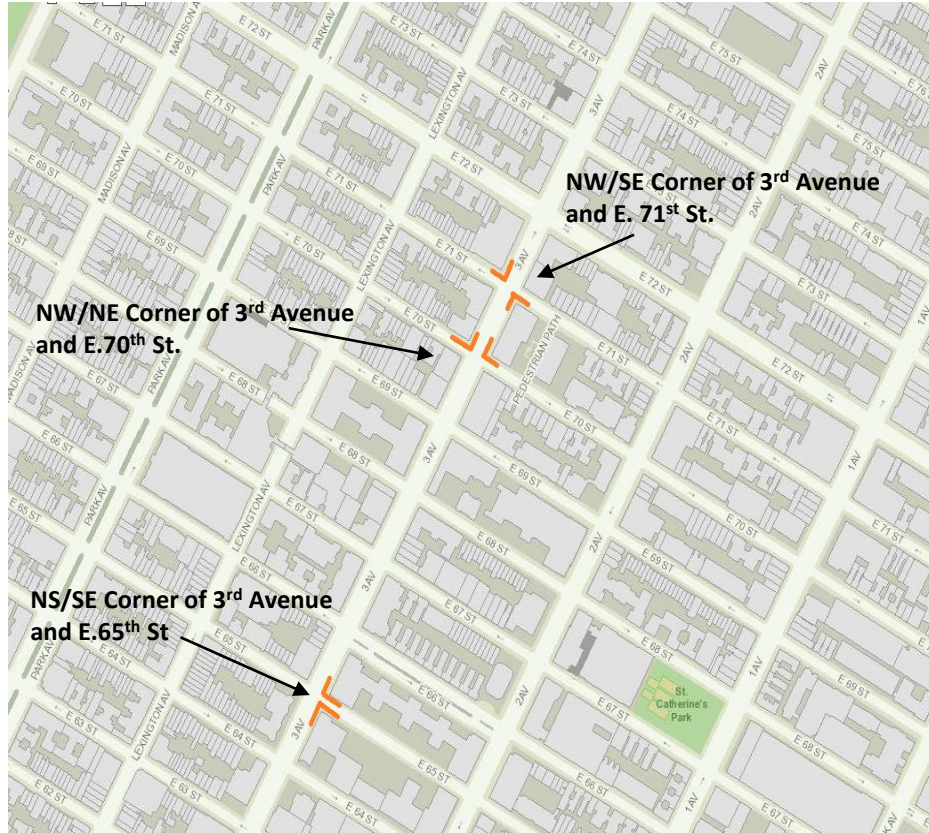

Work Operations

Type of Work:

- Installation of approximately a 3' to 6' wide by 1-1/2" deep pavement key in the roadway along proposed curb and in additional areas where and as directed by the Engineer
- Installation of Pedestrian Ramps with pigmented and unpigmented concrete sidewalk, embedded preformed detectable warning units and steel faced concrete curb.
- Installation of approximately a 3' to 6' wide by 1-1/2" deep wearing course in the roadway adjacent to new curb, and in possible additional areas.
- Possible relocation, modification and/or adjustments of existing drainage structures, hydrants, fire alarm facilities, and street lighting and traffic signal facilities.

Community Impacts & What to Expect

- DDC is committed to maintaining a work site that is safe and clean.
- Pedestrian access will be maintained during construction.
- Resident Engineer will monitor operations and work within Noise Code regulations.
- Sidewalk and/or loading dock access from the curb may be temporarily restricted while work is conducted (coordination will be arranged on a case by case basis)
- Parking may be temporarily restricted during construction.

Maintenance and Protection of Traffic (MPT)

- **A minimum of three (3) Interlocking pedestrian steel barricades shall be fastened together for stabilization, as directed by the Engineer.**
- **At heavy pedestrian traffic locations, a pedestrian walkway is to be provided.**
- **A flag person will be present as needed**
- **Traffic Safety Devices are to be installed prior to start of work and maintained until work is completed.**

This project entails the rehabilitation and upgrading of existing pedestrian ramps. This is a multiple location project and the overall anticipated completion of this project is Fall 2020. The permitted work hours will be Mondays through Fridays from 7:00AM to 6:00PM.

What Are the Community Impacts?

- The DDC is committed to maintaining a work site that is safe and clean. However, dust, noise and heavy equipment are common elements of construction and we ask for your patience during the project.
- There may be limited street access on certain blocks. However, deliveries to commercial and residential properties and emergency vehicle access will be allowed. In addition, the DDC will be baiting the construction zone on a regular basis to control rodent populations.

SOME THINGS TO REMEMBER:

- Weekend and night work may occur. Hours of operations on Saturdays and Sundays will be from 8:00AM to 6:00PM. If work occurs at nighttime, it will occur between the hours of 9:00PM and 6:00AM; advance notice will be provided to the community.
- Please follow all posted DOT's rules and regulations during non-construction hours. Emergency vehicle and Pedestrian access will be maintained at all times
- **Driveway/loading dock access** – may be temporarily restricted.
- **Vehicular access** – may be restricted on certain streets in certain locations.

Public Transportation

- **Bus Relocation** – where and when necessary, buses may be detoured in/around the work zones.

Pedestrian/Traffic

- **Pedestrian access**- to buildings will be maintained at all times.
- **Parking** - will be temporarily restricted so construction may proceed. Signs will be posted where necessary.

Student Pick-Up/Drop Off

- Where construction impacts school pick-up and drop-off areas, the DDC will coordinate with the NYC Department of Education (NYCDOE) and school officials to ensure these locations are safe, clearly marked and maintained.
- **Street closures/Traffic detours** – partial closures and/or limited access of intersections and streets. Half-block closures may be necessary. In the event of half-block closures, the street will be closed to through-traffic, but emergency vehicle access will be allowed. Signs will be posted.

- Access to driveways will be restricted within the work zone during work hours.
