Presentation by Cathy Chambers. The event is from 8 AM to 5 PM with breakdown till 6 PM. This is a Green Market (Farmer's Market) outside of St. Stephen's Church of Hungary. The curb and 10 ft. of the sidewalk are utilized. We received letters of support from Assembly Member Rebecca Seawright, Council Member Ben Kallos and Upper Greenside.

We also received and email from a neighbor requesting that the parking only to be restricted until 3 PM. A member for the public from Dorian's food market expressed concern that the Farmer's Market sells same of the same produce as her store and other brick and mortar stores. **6. 92nd Street Sunday Greenmarket** – Sidewalk and Curb Lane Closure at East 92 Street between First and York Avenues. On Sundays June 21, 2020 to November 22, 2020. From 8:00 AM to 5:00 PM

Presentation by Cathy Chambers. The Green Market (Farmer's Market) uses the curb and 10 ft. of the sidewalk. We received letters of support from Assembly Member Rebecca Seawright, Council Member Ben Kallos and Upper Greenside.

The owner form Dorian's food market again expressed her concern that the Farmer's Market sells some of the same produce that are sold in her store and other brick and mortar stores. She was not opposed to Farmer's Markets but believes the brick and mortar stores need assistance. A member of the committee asked if the tents can be moved closer to the curb to increase space for pedestrians. Cathy Chambers will meet with Ms. Johnson the first day the market opens in June.
