- 2. The applicant will keep the front of the establishment clean.
- 3. The applicant will be denied if they participate in bar-crawls.
- 4. The applicant will abide by applicable Covid-19 regulations at the time.

At the May 19, 2021 Full Board meeting of Community Board 8 Manhattan, the board **unanimously <u>approved</u>** the following resolution by a vote **of 46 in favor, 0 opposed, 0 abstentions and 0 not voting for cause**:

WHEREAS the applicant agreed to prevent noise emanating from the establishment and to ensure that no crowds congregate in front of the premises; and
