- 2. The applicant will keep the front of the establishment clean.
- 3. The applicant will be denied if they participate in bar-crawls.
- 4. The applicant will abide by applicable Covid-19 regulations at the time.

At the May 19, 2021 Full Board meeting of Community Board 8 Manhattan, the board **unanimously** <u>approved</u> the following resolution by a vote of 46 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

WHEREAS this is a New application for a Liquor, Wine, Beer, and Cider License; and

WHEREAS no one from the public objected; and

WHEREAS the applicant agreed to prevent noise emanating from the establishment and to ensure that no crowds congregate in front of the premises and shall provide Community Board 8 with a copy of their place of assembly certificate; and

WHEREAS the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls; therefore

BE IT RESOLVED that the application is APPROVED, subject to the stipulations above.
