Dear Deputy Commissioner Roberts,

**Applications will only be approved based upon the applicant's agreement to the following stipulations:**

- 1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.**
- 2. The applicant will keep the front of the establishment clean.**
- 3. The applicant will be denied if they participate in bar-crawls.**
- 4. The applicant will abide by applicable Covid-19 regulations at the time.**

At the November 17, 2021, Full Board meeting of Community Board 8 Manhattan, the board **approved** the following resolution by a vote of **46 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:**

**WHEREAS** this is a New application for a Liquor, Wine, Beer, and Cider License but in practice a transfer; and

**WHEREAS** no one from the public objected; and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls;

**WHEREAS** the food and drink ratio are 85% / 15%; therefore

**BE IT RESOLVED** that the application is **APPROVED**, subject to the stipulations above.
