Applications will only be approved based upon the applicant's agreement to the following stipulations:

- 1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
- 2. The applicant will keep the front of the establishment clean.
- 3. The applicant will be denied if they participate in bar-crawls.
- 4. The applicant will abide by applicable Covid-19 regulations at the time.

At the November 17, 2021, Full Board meeting of Community Board 8 Manhattan, the board **approved** the following resolution by a vote of **46 in favor**, **0 opposed**, **0 abstentions and 0 not voting for cause**:

WHEREAS this is a New application for a Liquor, Wine, Beer, and Cider License but in practice a transfer; and

WHEREAS no one from the public objected; and

WHEREAS the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls;

WHEREAS the food and drink ratio are 80% / 20%; therefore

BE IT RESOLVED that the application is APPROVED, subject to the stipulations above.
