Howard L. Zimmerman Architects & Engineers received the following documents to perform a second opinion peer review (for Mechanical and Plumbing only) regarding the changes to the Serafina commercial space:

• 7-25-2023 Serafina 3rd Avenue – Architectural Set

- 7-13-2023 Serafina 3<sup>rd</sup> Avenue Plumbing Issued for PAA
- 7-13-2023 Serafina 3<sup>rd</sup> Avenue Mechanical Issued for PAA

Additionally, we received a response letter "Serafina response to Howard Zimmerman 8.14.23\_171 E 84th" to our review #2 on 8/25/2023.

### Mechanical

- Mechanical plans provided do not include lower floor bathroom. Please provide plans and clarification of lower floor ventilation routing. Response letter indicated lower floor bathroom is pre-existing to Serafina's occupancy. There is an existing 6"x6" toilet exhaust riser in place, item closed.
- Provide more information regarding the kitchen hood suppression system, required by code.
   Confirmed hood will have precipitator and an ansul system. The ansul system will be supplied/filed/installed by Mega Mechanical and will have a minimum of 6 heads, item closed.
- Clarify maintenance and cleaning procedures of precipitator. Confirmed precipitator will be cleaned per manufacturer's requirements a minimum once every 3 months by Cobra Kitchen Ventilation INC., item closed
- New louvers to have directional blades pointing 45-degrees down. Confirm distance from street level to the precipitator exhaust louver. Must be minimum 10-feet per Mechanical code.
   Confirmed, item closed.

## <u>Plumbing</u>

- Provide additional information regarding proposed grease interceptor. Confirm grease interceptor
  conforms to PDI G101, ASME A112.14.3 or ASME A112.14.4 and shall be installed in
  accordance with the manufacturer's instructions. Plumber confirmed the grease trap installed
  was filed and installed per code and the referenced standards, item closed.
- Lower Floor bathroom was not included in filing set provided on 4-12-22 but is not bubbled. Is bathroom existing or new to scope? Provide clarification. Response letter indicated lower floor bathroom is pre-existing to Serafina's occupancy, item closed.
- Provide locations of existing sanitary risers that new proposed fixtures will tie in to. Provide slope
  of sanitary piping and confirmation new sanitary piping to tie into existing sanitary stack per NYC
  plumbing code requirements. Plumber confirmed worked was filed with the DOB and
  installed per code. The sanitary piping slope is ¼" per food and connected to the existing
  building stack located behind the grease trap in the building's storage area.



At this time, all comments and concerns have been addressed. All necessary steps to ensure the new installations are code compliant and will not negatively impact the building are being taken. HLZAE has no further comments at this time.
