Dear Mr. Beirne and the Members of Community Board 8 Manhattan.

I am the Interim Director of Operations for Syracuse University's Joseph I. Lubin House, which holds a liquor license at 11 East 61st Street.

The Joseph I Lubin House has operated at this location since 1964. It is a townhouse that provides accommodations to Syracuse University employees and faculty while in Manhattan on business. It also offers alumnae gatherings, discussion panels and art exhibits and other similar events.

The University recently submitted its application to renew its liquor license. Unfortunately, the required 30 day notice to the Community Board was delayed due to an unintended oversight. We at the University completely acknowledge that 30 day notice is required upon liquor license renewal and the University did send the notice on August 16, 2023.

The University understands and acknowledges the Community Board's role as advocates and service coordinators for the community and its residents. In light of the premises' long history of serving as a good neighbor and providing a benefit to the community, we would respectfully request that the Community Board agree to waive the 30 day period. Only a short period of time is affected – the 30 day period would otherwise expire in just about 2 weeks.

The existing liquor license is expiring, and the Liquor Authority can issue the renewed license if the Community Board sees fit to grant the requested waiver. We would like to assure the Community Board that this is merely a standard liquor license renewal – there will be no changes whatsoever to the premises or the way it operates. We also understand and acknowledge that this is a one time waiver and that further waiver requests will not be accepted.

In addition, if you would like us to attend the Community Board meeting in October, we are certainly willing to do that. However, we would request that the Board consider approving the

waiver request before October 3, as the 30 day period will have expired by then and the request for the waiver would therefore be moot.
