- 1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
- 2. The applicant will not use any unlawful motorized vehicle for deliveries and ensure that any thirdparty delivery service you contract with does not use any unlawful motorized vehicle
- 3. The applicant will have delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any contracted third-party delivery service shall wear proper attire such as helmets, identifiable clothing etc.
- 4. The applicant will not participate in bar-crawls or the cannabis equivalent

At the Full Board meeting of Community Board 8 Manhattan held on February 21, 2024, the board approved the following resolution by a vote of 34 in favor, 1 opposed, 0 abstentions and 0 not voting for cause:
