- 1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
- 2. The applicant will not use any unlawful motorized vehicle for deliveries and ensure that any thirdparty delivery service you contract with does not use any unlawful motorized vehicle
- 3. The applicant will have delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any contracted third-party delivery service shall wear proper attire such as helmets, identifiable clothing etc.
- 4. The applicant will not participate in bar-crawls

At the Full Board meeting of Community Board 8 Manhattan held on April 17, 2024, the board unanimously approved the following resolution by a vote of 42 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

WHEREAS this is a New application for a Liquor, Wine, Beer, and Cider License and Temporary Retail Permit; and

WHEREAS no one from the public objected; and

WHEREAS the applicant agreed to the stipulation that the rear yard will not be used unless the applicant has the lawful right to do so, such as by a certificate of occupancy or letter of no objection, and

WHEREAS the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls and; therefore

BE IT RESOLVED that the application is APPROVED, subject to the stipulations above.
