- 3. The applicant will have delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any contracted third-party delivery service shall wear proper attire such as helmets, identifiable clothing etc.
- 4. The applicant will not participate in bar-crawls

At the Full Board meeting of Community Board 8 Manhattan held on April 17, 2024, the board approved the following resolution by a vote of 41 in favor, 0 opposed, 0 abstentions and 1 not voting for cause:
