Dear Borough Commissioner Pinciar,

Applications will only be approved based upon the applicant's agreement to the following stipulations:

1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
2. The applicant will only use lawful vehicles and/or means of transportation for deliveries and ensure third party delivery services do the same
3. The applicant will require delivery persons to wear the proper attire such as helmet, identifiable clothing, etc., and they will ensure that any delivery service we contract with shall wear proper attire such as helmets, identifiable clothing, etc.
4. The applicant will be denied if they participate in bar or pub crawls
5. The applicant will remove any unlawful existing structures

At the Full Board meeting of Community Board 8 Manhattan held on May 15, 2024, the board approved the following resolution by a vote of 44 in favor, 1 opposed, 0 abstentions and 0 not voting for cause:

**WHEREAS** this is a New application for an Outdoor dining – unenclosed sidewalk cafe; and

**WHEREAS** no one from the public objected; and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls and to the stipulation to limit outdoor service to no later than 10pm; therefore

**BE IT RESOLVED** that the application is **APPROVED, subject to the stipulations above.**
