Chair Valerie S. Mason called the meeting to order at 6:30 PM.

1. Public Hearing - 60 East 93rd Street, Taboulehs LLC. A Special Permit is being sought by private applicant TABOULEHS LLC pursuant to ZR 74-711 to waive bulk regulations to facilitate a change of use for an existing 4-story landmark building, including community facility use up to the 3rd floor and residential use on the 4th floor, to a 4-story single residential building at 60 East 93rd Street (block 1504, lot 45) within the Expanded Carnegie Hill Historic District.

WHEREAS this is an application pursuant to ZR 74-711 to waive bulk regulations to facilitate a change of use for an existing 4-story landmark building, including community facility use up to the 3rd floor and residential use on the 4th floor, to a 4-story single residential building at 60 East 93rd Street (block 1504, lot 45) within the Expanded Carnegie Hill Historic District.; and

WHEREAS the application was previously unanimously approved by Community Board 8 in January 2023 as part of their Landmarks Preservation Commission application; therefore

BE IT RESOLVED Community Board 8 approves this application as presented.

Community Board 8 Manhattan approved this resolution by a vote of 37 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

2. Public Hearing - City of Yes for Housing Opportunity. A citywide zoning text amendment from the Department of City Planning to expand opportunities for housing within all zoning districts, and across all 59 of the City's Community Districts. These changes to the City's Zoning Resolution would enable more housing and a wider variety of housing types in every neighborhood, from the lowest-density districts to the highest, to address the housing shortage and high cost of housing in New York City.

The board conducted discussions and took straw polls on the 15 different goals and project components associated with the COYHO citywide zoning text amendment. These will be compiled into one resolution to be voted on at the June 26, 2024 Full Board Meeting.
