RE: KandLelight, LLC., 1705 First Avenue (Between East 88th Street and East 89th Street) New Application and Temporary Retail Permit for a Liquor, Wine, Beer, and Cider License

Dear Deputy Commissioner Benedetto,

Applications will only be approved based upon the applicant's agreement to the following stipulations:

1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
2. The applicant will only use lawful vehicles and/or means of transportation for deliveries and ensure third-party delivery services do the same.
3. The applicant will require delivery persons to wear the proper attire, such as helmet, identifiable clothing, etc., and they will ensure that any delivery service they contract with shall wear proper attire such as helmets, identifiable clothing, etc.
4. The applicant will be denied if they participate in bar-crawls.
5. Where the applicant has any outdoor dining space, either a sidewalk café or roadway dining, the applicant agrees that they shall not serve alcohol in those outdoor spaces beyond 10 PM.
6. Where the applicant has the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), they shall cease use of such space no later than 10 PM.
7. The applicant will remove the Street Life Committee meeting notices they posted following the Street Life meeting and prior to the next applicable Full Board meeting.

At the Full Board meeting of Community Board 8 Manhattan held on September 18, 2024, the board unanimously approved the following resolution by a vote of 38 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

WHEREAS this is a New application for a Liquor, Wine, Beer, and Cider License and Temporary Retail Permit;
and

WHEREAS no one from the public objected; and

WHEREAS the applicant has agreed to Community Board 8's stipulations above; and

WHEREAS the applicant has agreed to agree to be in compliance with all DoT regulations on sidewalk cafes;
therefore

BE IT RESOLVED that the application is **APPROVED**, subject to the stipulations above.
