**RE: Arturo's Park INC, dba Arturo's, 1617 York Avenue (Between East 85th Street and East 86st Street) New Outdoor Dining Application for a Roadway Café – 3 Tables and 12 Chairs**

Dear Borough Commissioner Pincar,

**Applications will only be approved based upon the applicant's agreement to the following stipulations:**

- 1. Abide by the NYC bicycle laws and guidelines and shall ensure that any third party delivery service you contract with abides by the laws and guidelines,**
- 2. Will only use lawful vehicles and/or means of transportation for deliveries and ensure any third party delivery services do the same,**
- 3. Have my delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any third party delivery service I contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. Not to participate in bar or pub crawls**
- 5. Remove any unlawful existing structures**
- 6. If you have any outdoor dining space, either a sidewalk café or roadway dining, not serve alcohol in those outdoor spaces beyond 10 PM.**
- 7. If you have the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), cease use of such space no later than 10 PM.**
- 8. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on October 23, 2024, the board unanimously approved the following resolution by a vote of 39 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

**WHEREAS** this is a New Outdoor Dining Application for a Roadway Café – 3 tables and 12 chairs.

**WHEREAS** no one from the public objected;

**WHEREAS** the applicant has agreed to Community Board 8's stipulations that they be in compliance with all Department of Transportation regulations for outdoor dining and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations above; therefore

**BE IT RESOLVED** that the application is **APPROVED**, subject to the stipulations above.
