**RE: LPB 7 LLC, dba La Pecora Bianca, 1562 Second Avenue (Between East 81st Street and East 82nd Street) New Outdoor Dining Application for a Roadway/Unenclosed Sidewalk Café – 10 Tables and 20 Chairs/22 Tables and 44 Chairs**

Dear Borough Commissioner Pincar,

**Applications will only be approved based upon the applicant’s agreement to the following stipulations:**

- 1. Abide by the NYC bicycle laws and guidelines and shall use commercially reasonable efforts to ensure that any third party delivery service you contract with abides by the laws and guidelines,**
- 2. Will only use lawful vehicles and/or means of transportation for deliveries and will use commercially reasonable efforts to any third party delivery services do the same,**
- 3. Have my delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and will use commercially reasonable efforts to ensure that any third party delivery service I contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. Not to participate in bar or pub crawls**
- 5. Remove any unlawful existing structures**
- 6. If you have any outdoor dining space, either a sidewalk café or roadway dining, not serve alcohol in those outdoor spaces beyond 10 PM.**
- 7. If you have the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), cease use of such space no later than 10 PM.**
- 8. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on October 23, 2024, the board approved the following resolution by a vote of 29 in favor, 10 opposed, 0 abstentions and 0 not voting for cause:

**WHEREAS** this is a New Outdoor Dining Application for a Roadway/Unenclosed Sidewalk Café – 10 Tables and 20 Chairs and Roadway 22 tables and 44 chairs.

**WHEREAS** no one from the public objected;

**WHEREAS** the applicant has agreed to Community Board 8’s stipulations that they be in compliance with all Department of Transportation regulations for outdoor dining and

**WHEREAS** the applicant has agreed to Community Board 8’s stipulations above; therefore

**BE IT RESOLVED** that the application is **APPROVED**, subject to the stipulations above.
