Dear Borough Commissioner Pincar,

Applications will only be approved based upon the applicant's agreement to the following stipulations:

- 1. Abide by the NYC bicycle laws and guidelines and shall ensure that any third party delivery service you contract with abides by the laws and guidelines,**
- 2. Will only use lawful vehicles and/or means of transportation for deliveries and ensure any third party delivery services do the same,**
- 3. Have my delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any third party delivery service I contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. Not to participate in bar or pub crawls**
- 5. Remove any unlawful existing structures**
- 6. If you have any outdoor dining space, either a sidewalk café or roadway dining, not serve alcohol in those outdoor spaces beyond 10 PM.**
- 7. If you have the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), cease use of such space no later than 10 PM.**
- 8. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on October 23, 2024, the board unanimously approved the following resolution by a vote of 39 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

WHEREAS this is a New Outdoor Dining Application for a Roadway Café – 5 tables and 10 chairs.

WHEREAS no one from the public objected;

WHEREAS the applicant has agreed to Community Board 8's stipulations that they be in compliance with all Department of Transportation regulations for outdoor dining and

WHEREAS the applicant has agreed to Community Board 8's stipulations above; therefore

BE IT RESOLVED that the application is **APPROVED**, subject to the stipulations above.
