Item 1A: <u>1379 Water and Wheat LLC, dba TBD, 1379 Third Avenue (Between East 78th and East 79th</u> <u>Streets) New Application and Temporary Retail Permit for Wine, Beer and Cider</u>

WHEREAS no one from the public objected; and

WHEREAS the applicant has agreed to Community Board 8's stipulations concerning delivery bikes and bar crawls and to the stipulation to limit outdoor service to no later than 10pm; therefore

BE IT RESOLVED that the application is APPROVED, subject to the stipulations above.

Item 2: Approval of Public Artworks Installation at 103rd Street

THEREFORE, BE IT RESOLVED Community Board 8 Manhattan approves the installation of Vinnie Bagwell's new Victory Statue to be located at 103rd Street and Central Park.

Item 3: <u>Approval to Explore Converting 4 of the 8 Handball Courts at Stanley Isaacs Park to Pickleball</u> <u>Courts</u>

THEREFORE, BE IT RESOLVED Community Board 8 Manhattan supports the Parks Department conversion of four of the eight handball courts at Stanley Isaacs to pickleball courts as soon as possible.

Community Board 8 Manhattan unanimously approved these resolutions by a vote of 45 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.

C. Landmarks Committee – Anthony Cohn and David Helpern, Co-Chairs

LM-1: Item 1

Item 1: 49 East 67th Street (Upper East Side Historic District)

WHEREAS 49 East 67th Street is a single-family five-story building on the north side of East 67th Street between Madison and Park Avenues and contributes to the character of the Upper East Side Historic District; and

WHEREAS 49 East 67th Street is a fine example of the renovation work of the architectural firm of Sterner and Wolfe, who were active on the Upper East Side in the first two decades of the 20th Century; and

WHEREAS the applicant proposes to recreate the original Juliet balconies at the second floor to their original appearance, which can be approved at Landmarks Commission staff level; and

WHEREAS the applicant wishes to alter the front door by replacing the existing painted wood door with a painted wrought iron and glass door; and

WHEREAS the proposed door will take its visual cues from the restored railings; and

WHEREAS the existing door is not original and is not painted the same color as the original; and

WHEREAS the proposed door represents a significant change in both material and appearance; and

WHEREAS although the project has been well thought-out and thoroughly documented, it is inappropriate in detail and inappropriate to the period evoked by the design; and

THEREFORE, BE IT RESOLVED that this application is APPROVED as presented.

Community Board 8 Manhattan approved this resolution by a vote of 30 in favor, 15 opposed, 0 abstentions, and 0 not voting for cause.

D. Sanitation and Environment Committee – Sahar Husain, Addeson Lehv, and Barbara Rudder, Co-Chairs

SAN-1: Items 1A, 1B - Unanimous Approvals

Item 1A: Monies for Food Scrap Collection at Green Markets

WHEREAS: Composting is a tool for climate control by providing rich, absorbent soil for use to green, and protect our community, and;

WHEREAS: Green markets have successfully generated thousands of pounds of compost, and;

WHEREAS: New York City has not included funding in its budget for green market food waste collection, including four markets in Community Board 8 Manhattan, East 82nd and 92nd Streets, Lenox Hill, Robbins Plaza, and Roosevelt Island, and;

WHEREAS: The funds needed are an insignificant portion of the Sanitation Department's budget, therefore:

BE IT RESOLVED: Community Board 8 Manhattan recommends the Mayor and City Council to reinstate monies in the FY25 budget for food scrap collection at green markets.

Item 1B: Funding of Local Compost Centers

WHEREAS: Composting is key to reversing the effects of greenhouse gasses in our atmosphere, and;

WHEREAS: Local composting sites, such as Big Reuse under the Queensboro Bridge that services Roosevelt Island, convert food scraps into compost used for greening our community, and;

WHEREAS: New York City has not included funding for local composting sites in its budget, which is a small percentage of the overall Sanitation budget, and;

WHEREAS: There's a possibility Big Reuse will be evicted from its current site, therefore;

BE IT RESOLVED: Community Board 8 Manhattan recommends New York City to fund local compost centers in the FY25 budget, and;

BE IT FURTHER RESOLVED: Community Board 8 Manhattan requests that the City take actions to prevent the eviction of Big Reuse from its current location under the Queensboro bridge that services Roosevelt Island.

Community Board 8 Manhattan unanimously approved these resolutions by a vote of 45 in favor, 0 opposed, 0 abstentions, and 0 not voting for cause.
