**RE: 1475 Second Avenue Bagel, LLC dba Pick A Bagel, 1475 Second Avenue (Between East 76th Street and East 77th Street) New Outdoor Dining Application for a Sidewalk Café – Unenclosed – 11 Tables and 22 Chairs**

Dear Borough Commissioner Pincar,

**Applications will only be approved based upon the applicant's agreement to the following stipulations:**

- 1. The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.**
- 2. The applicant will only use lawful vehicles and/or means of transportation for deliveries and ensure third party delivery services do the same**
- 3. The applicant will require delivery persons to wear the proper attire such as helmet, identifiable clothing, etc., and they will ensure that any delivery service we contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. The applicant will be denied if they participate in bar or pub crawls**
- 5. The applicant will remove any unlawful existing structures**
- 6. The applicant will remove the Street Life Committee meeting notices they posted following the Street Life meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on September 18, 2024, the board unanimously approved the following resolution by a vote of 38 in favor, 0 opposed, 0 abstentions and 0 not voting for cause:

**WHEREAS** this is a New Outdoor Dining Application for a Sidewalk Café – Unenclosed – 11 tables and 22 chairs;  
and

**WHEREAS** no one from the public objected; and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations that they be in compliance with all Department of Transportation regulations for outdoor dining; and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations above; therefore

**BE IT RESOLVED** that the application is **APPROVED**, subject to the stipulations above.
