- The applicant will abide by the bicycle guidelines and will ensure that any third-party delivery provider that it contracts with shall abide by the bicycle guidelines.
- The applicant will not use any unlawful motorized vehicle for deliveries and ensure that any third-party delivery service you contract with does not use any unlawful motorized vehicle
- The applicant will have delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any contracted third-party delivery service shall wear proper attire such as helmets, identifiable clothing etc.
- The applicant will not participate in bar-crawls or the cannabis equivalent
- 5. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.

At the Full Board meeting of Community Board 8 Manhattan held on September 18, 2024, the board approved the following resolution by a vote of 36 in favor, 1 opposed, 1 abstention and 0 not voting for cause:

WHEREAS this is a new application for a retail dispensary; and

WHEREAS the community cited concerns about prior use of the space to sell cannabis unlawfully prior to the applications;

WHEREAS the community cited concerns about the proximity between the location and nearby schools;

WHEREAS the applicant has agreed to Community Board 8's stipulations; therefore

BE IT RESOLVED that the application is DISAPPROVED, subject to the stipulations above.
