**RE: 1291 Pub INC., dba JG Melon, 1291 Third Avenue (Between East 74th Street and East 75th Street) New Outdoor Dining Application for a Roadway Café – 5 Tables and 14 Chairs**

Dear Borough Commissioner Pincar,

**Applications will only be approved based upon the applicant's agreement to the following stipulations:**

- 1. Abide by the NYC bicycle laws and guidelines and shall make all reasonable efforts to ensure that any third-party delivery service you contract with abides by the laws and guidelines.**
- 2. Will only use lawful vehicles and/or means of transportation for deliveries and make all reasonable efforts to ensure any third-party delivery services do the same.**
- 3. Have my delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and make all reasonable efforts to ensure that any third-party delivery service I contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. Not to participate in bar or pub crawls.**
- 5. Will comply and remain in compliance with all DOT rules and regulations for outdoor cafés, including the removal of any unlawful existing structures.**
- 6. If you have any outdoor dining space, either a sidewalk café or roadway dining, not serve alcohol in those outdoor spaces beyond 10 PM.**
- 7. If you have the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), cease use of such space no later than 10 PM.**
- 8. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on April 16, 2025, the board approved the following resolution by a vote of 36 in favor, 5 opposed, 0 abstentions, and 0 not voting for cause:

**WHEREAS** this is a New Application to the Department of Transportation for a Roadway Café – 5 Tables and 14 Chairs; and

**WHEREAS** no one from the public objected; and

**WHEREAS** the applicant indicated they will only be applying for a Third Avenue Roadway Café and nothing on East 74th Street bringing the total to 5 tables and 14 chairs; and

**WHEREAS** the applicant has agreed to Community Board 8's stipulations above; therefore

**BE IT RESOLVED** that the application is **APPROVED, subject to the stipulations above.**
