RE: E.A.T. is owned by ELI ZABAR INC., dba E.A.T. CAFE, 1064 Madison Avenue (Between East 80th Street and East 81st Street) New Outdoor Dining Application for a Roadway Café – 29 Tables and 58 Chairs

Dear Deputy Commissioner Sta. Ines,

Applications will only be approved based upon the applicant's agreement to the following stipulations:

- 1. Abide by the NYC bicycle laws and guidelines and shall make all reasonable efforts to ensure that any third-party delivery service you contract with abides by the laws and guidelines.**
- 2. Will only use lawful vehicles and/or means of transportation for deliveries and make all reasonable efforts to ensure any third-party delivery services do the same.**
- 3. Have my delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and make all reasonable efforts to ensure that any third-party delivery service I contract with shall wear proper attire such as helmets, identifiable clothing, etc.**
- 4. Not to participate in bar or pub crawls.**
- 5. Will comply and remain in compliance with all DOT rules and regulations for outdoor cafés, including the removal of any unlawful existing structures.**
- 6. If you have any outdoor dining space, either a sidewalk café or roadway dining, not serve alcohol in those outdoor spaces beyond 10 PM.**
- 7. If you have the right to lawfully use any outdoor rear yard space (enclosed or unenclosed), cease use of such space no later than 10 PM.**
- 8. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.**

At the Full Board meeting of Community Board 8 Manhattan held on April 16, 2025, the board approved the following resolution by a vote of 22 in favor, 18 opposed, 0 abstentions, and 0 not voting for cause:

WHEREAS this is a New Application to the Department of Transportation for a Roadway Café – 29 Tables and 58 Chairs; and

WHEREAS Community Board 8 considers the size of the Roadway Café (29 Tables and 58 Chairs) too large; and

WHEREAS Community Board 8 believes restaurants of this size should rent out other commercial buildings available, rather than apply for large Roadway Cafés; therefore

BE IT RESOLVED that the application is **DISAPPROVED**, subject to the stipulations above.

This resolution supersedes the resolution dated April 2, 2025, issued following the CB8M Street Life Committee meeting and sent before the DOT deadline for this application.

Please advise this office of any action taken regarding this matter.
