- 2. Not use any unlawful motorized vehicle for deliveries and ensure that any third-party delivery service you contract with does not use any unlawful motorized vehicle
- 3. Have delivery persons wear the proper attire such as helmets, identifiable clothing, etc. and ensure that any contracted third-party delivery service shall wear proper attire such as helmets, identifiable clothing, etc.
- 4. Not to participate in bar or pub crawls or the cannabis equivalent
- 5. Remove the Street Life Committee meeting notices you posted following the Street Life Committee meeting and prior to the next applicable Full Board meeting.

At the Full Board meeting of Community Board 8 Manhattan held on May 21, 2025, the board approved the following resolution by a vote of 22 in favor, 16 opposed, 2 abstentions and 0 not voting for cause:

WHEREAS this is a New Application for an Adult-use Retail Dispensary License; and

WHEREAS no one from the public objected; and

WHEREAS members of the community expressed concerned about the establishment's proximity to nearby schools and churches; and

WHEREAS the applicant has agreed to Community Board 8's stipulations above; therefore

BE IT RESOLVED that the application is DISAPPROVED, subject to the stipulations above.
