Item 1: Public Hearing: Presentation from the New York Department of Social Services, The Department of Homeless Services, and Housing Solutions of New York (Provider) – Restore Hope Women’s Shelter

The Department of Homeless Services and its contracted shelter operator, Housing Solutions of New York, gave a presentation on the Restore Hope Women’s Shelter. The presentation also included remarks from representatives of Elite Investigations, the private security firm for the shelter. The presentation slides and a full recording are available online at cb8m.com.

A public hearing followed. Some members of the community expressed concerns related to security, quality of life issues, the accommodations in the shelter, the community notification process, and other issues. Other members of the community expressed support for the shelter plan and remarked on the importance of contributing to solutions for the city’s housing crisis. Representatives from the Department of Homeless Services, Housing Solutions of New York, Elite Investigations, and the NYPD answered questions as they arose.

Members of Community Board 8 offered remarks and asked questions about the shelter, including questions related to:

- Statistics on shelter populations
- Statistics on quality of life and public safety in the vicinity of other shelters citywide
- General shelter operations and programming
- Shelter approval timelines
